Upon consideration of the Plaintiff's Motion for Judgment By Default, the Affidavit attached thereto, proper service of the Summons and complaint having been made on the Debtor, and the default of the Debtor having been entered for failing to plead or otherwise defend this

adversary proceeding as required by law, it is, by the United States Bankruptcy Court for the District of Maryland,

ORDERED, that the Motion Judgment by Default is hereby GRANTED; and it is further **ORDERED**, that Corey W. Hankerson shall turnover \$1,500 to Ms. Moses, the Debtor in case No., 10-18256 and \$1,500 to Mr. Bradford, the Debtor in Case No., 10-21332 for violations of §§ 110(b), 110(c), 110(d), 110(e), or 110(g) of the United States Bankruptcy Code; and it is further

ORDERED, that Corey W. Hankerson shall pay Ms. Moses and Mr. Bradford \$3,000 each for his violations of §§ 110(b), 110(c), 110(d), 110(e), or 110(g) of the United States Bankruptcy Code and for his fraudulent, unfair and deceptive acts; and it is further

ORDERED, that all payments due to Ms. Moses and Mr. Bradford are due in the form of a cashier's check payable to the appropriate debtor and delivered to the Office of the U.S.

Trustee, 101 W. Lombard Street, Suite 2625, Baltimore, MD 21201 within ten (10) days of the entry of this Order; and it is further

ORDERED, that Corey W. Hankerson is fined and shall pay \$6,000 for his violations of 11 U.S.C. § 110(b) and (c) in Ms. Moses' case which violations fail to disclose the identity of Mr. Hankerson; and it is further

ORDERED, that Mr. Hankerson is fined and shall pay \$3,500 for the other violations of 11 U.S.C. §§ 110(b), 110(c), 110(d), 110(e), 110(g), 110(g) or 110(h) described in the Complaint; and it is further

ORDERED, that all fines are due in the form of a cashier's check payable to the "Registry of Court" and delivered to the Office of the U.S. Trustee, 101 W. Lombard Street, Suite 2625, Baltimore, MD 21201 within ten (10) days of the entry of this Order; and it is further ORDERED, that the entry of this Order shall serve to enjoin Mr. Hankerson from (I)

acting as a bankruptcy petition preparer, (ii) filing any documents in this Court other than papers filed on his own behalf, or (iii) otherwise violating §§ 110 of the United States Bankruptcy Code until this injunction is modified by further Order of this Court.
