CONSENT ORDER RESOLVING UNITED STATES TRUSTEE'S MOTION FOR ORDER DIRECTING BERNARD RICHARDSON a.k.a. BERNARD RICHERSON TO APPEAR AND SHOW CAUSE

This matter came before the Court at a hearing on April 27, 2005, on the Court's Order Continuing Hearing on Order to Show Cause, dated March 4, 2005. On February 17, 2005, this Court issued an Order Holding Bernard Richardson a/k/a Bernard Richerson ("Bernard Richardson") in Contempt of Court and Bench Warrant for Apprehension of Him by the United States Marshal, which Order was in response to Mr. Richardson's failure to appear at a December 15, 2004, hearing in respect of the Court's Second Order that Bernard Richardson a/k/a Bernard Richerson Appear and Show Cause why he should not be held in civil contempt, pursuant to Rule 9020 of the Federal Rules of Bankruptcy Procedure, for failing to comply with this Court's Order for Judgment by Default Entered April 19, 2002. Bernard Richardson was thereafter apprehended and brought before the Court on March 1, 2005, wherein he was instructed to (1) provide the United States Trustee's Office with certain information relating to his activities as a bankruptcy petition preparer, and (2) keep the United States Trustee's Office apprized of his current address and telephone number. Bernard Richardson was also advised that the hearing in respect to the Order to Show Cause would be continued to March 23, 2005 at 11:00 a.m. for which he must appear personally; failure to appear or to bring the requested information would result in a fine of \$100 per day for each day of noncompliance.

On March 23, 2005, Bernard Richardson appeared in Court and requested, with the consent of the United State Trustee, a continuance because his counsel could not be present that day. The Court granted the continuance and rescheduled the hearing in respect to the Order to Show Cause for April 27, 2005 at 3:00 p.m.

Bernard Richardson failed to appear at the April 27, 2005, hearing.

On March 30, 2006, Bernard Richardson, with counsel, met with counsel for the United States Trustee for the purpose of resolving that United States Trustee's Motion for Order Directing Bernard Richardson a.k.a. Bernard Richerson to Appear and Show Cause.

ORDERED the Bernard Richardson, or any person working under his direction, control or employment or in any type of business organization or entity that he may create, or in which he may have an ownership interest, are hereby permanently enjoined:

Accordingly, IT IS for the United States Bankruptcy Court for the District of Maryland

(1) from acting as a bankruptcy petition preparer;

(2) from preparing or filing, or assisting in preparing for filing, a petition or any other document by a debtor in any court in the United States in connection with a case under Title 11 of the United States Code, regardless of whether or not such activities are performed for compensation;

(3) from the unauthorized practice of law; and

(4) from providing legal advice regarding bankruptcy, including, but not limited to, advising as to the need to file a bankruptcy case, the chapter under which to file, and the difference between the various chapters of bankruptcy; and it is further

ORDERED that any violation of this Order will result in a fine of \$3,500 per violation to be assessed against Bernard Richardson and payable to the Office of the United States Trustee; and it is further

ORDERED that the Order for Judgment by Default entered by this Court or April 19, 2002, is still and shall remain in full force and effect.
