2 JUDGMENT BY DEFAULT DECLARING  
3 DEBTS NONDISCHARGEABLE AND FOR  
4 AMOUNT OF DEBT

5 Plaintiffs having heretofore filed a complaint to determine  
6 the dischargeability of certain debts, the Defendant having been  
7 duly served with process and having failed to plead or otherwise  
8 defend in this action, upon application of the Plaintiffs and upon  
9 affidavits that Defendant is indebted to Plaintiffs in certain  
10 amounts and that Defendant is not an infant or incompetent person  
11 and is not in the military service of the United States, the Court  
12 adjudges as follows:

13 1. The debts owed to the Plaintiffs, Darius Doorandish,  
14 Thomas Emerson, Thomas Serb and Carol Serb, his wife, Robert Foltz  
15 and Kathy Foltz, his wife, Olga M. Bruning and Linda Freeman by  
16 the Defendant debtor Milton Edward Siegert, Jr., a/k/a Ed Siegert  
17 for which judgments are hereinafter granted to Plaintiffs, should  
18 be and hereby are excepted from the discharge granted to the  
19 Defendant debtor in the above entitled bankruptcy case.

20 2. Plaintiff, Darius Doorandish is awarded judgment against  
21 the Defendant Milton Edward Siegert, Jr., a/k/a Ed Siegert for  
22 the total amount of Seven Thousand, Three Hundred and Fifty Dollars  
23 (\$7,350.00) plus interest at the legal rate of ~~7.66%~~ <sup>8.75%</sup>  
24 from the date of this judgment until paid, plus costs of \$20.00.

25 3. Plaintiff, Thomas Emerson is awarded judgment against  
26 the Defendant, Milton Edward Siegert, Jr., a/k/a Ed Siegert for  
27 the total amount of One Thousand, Eight Hundred and Ninety Dollars

2 (\$1,890.00) plus interest at the legal rate of <sup>875</sup> 7.66 percent  
3 from the date of this judgment until paid, plus costs of \$20.00.

4 4. Plaintiffs, Thomas Serb and Carol Serb, his wife, are  
5 awarded judgment against the Defendant, Milton Edward Siegert, Jr.,  
6 a/k/a Ed Siegert for the total amount of Ten Thousand, Four Hundred  
7 and Sixty Nine Dollars and Nine Cents (\$10,469.09) plus interest  
8 at the legal rate of <sup>875</sup> 7.66 percent from the date of this  
9 judgment until paid, plus costs of \$20.00.

10 5. Plaintiffs, Robert Foltz, and Kathy Foltz, his wife, are  
11 awarded judgment against the Defendant, Milton Edward Siegert, Jr.,  
12 a/k/a Ed Siegert for the total amount of Three Thousand, Five  
13 Hundred Dollars (\$3,500.00) plus interest at the legal rate of  
14 <sup>875</sup> 7.66 percent from the date of this judgment until paid, plus  
15 costs of \$20.00.

16 6. Plaintiff, Olga M. Bruning is awarded judgment against  
17 the Defendant, Milton Edward Siegert, Jr., a/k/a Ed Siegert for  
18 the total amount of Eight Thousand, Eight Hundred and Eighty Four  
19 Dollars and sixty two cents (\$8,884.62) plus interest at the legal  
20 rate of <sup>875</sup> 7.66 percent from the date of this judgment until  
21 paid, plus costs of \$20.00.

22 7. Plaintiff, Linda Freeman is awarded judgment against  
23 the Defendant, Milton Edward Siegert, Jr., a/k/a Ed Siegert for  
24 the total amount of Five Thousand, Two Hundred and Seventy Two  
25 Dollars and five cents (\$5,272.05) plus interest at the legal  
26 rate of <sup>875</sup> 7.66 percent from the date of this judgment until  
27 paid plus costs of \$20.00.
