ORDER GRANTING MOTION FOR SUMMARY JUDGMENT

Upon consideration of Bristen Office Concepts, Inc.'s Motion for Summary Judgment Against Champon Flavors, Inc. and IBI Flavor Ingredients, Inc., the Court finds:

1. That there is no genuine dispute as to material issues of fact;
2. That Judgment was entered in favor of Bristen Office Concepts, Inc. against a joint venture, Products Ingredients Technology, Inc., on June 2, 1991;
3. That the evidence at the trial in this case showed that the sole joint venture owners of Products

Ingredients Technology, Inc. are Champon Flavors, Inc. and IBI Flavor Ingredients, Inc.;


4. That Champon Flavors, Inc. and IBI Flavor Ingredients, Inc. were properly served with copies of the Amended Complaint; and

5. That Champon Flavors, Inc. and IBI Flavor Ingredients, Inc. have failed to answer or respond to the Amended Complaints.

It is this 18th day of May, 1992 by the United States Bankruptcy Court for the District of Maryland,

ORDERED that the Motion be, and the same hereby is, GRANTED; and Judgment is entered in favor of Bristen Office Concepts, Inc., jointly and severally against Champon Flavors, Inc. and IBI Flavor Ingredients, Inc., in the amount of \$56,977.93, with attorneys' fees of \$11,395.59, plus costs and interest at 18% per annum.
