ORDERED this 16 day of Dec, 1991, that  
Judgement in the amount of Fourteen Thousand, Two Hundred  
Thirty Dollars and Eighty-Four Cents (\$14,230.84) is hereby  
entered in favor of the Plaintiff, Cumis Insurance Society,  
Inc., against the Defendant, John F. Bourgeois, with a Stay of  
Execution and it is further


ORDERED, that the Debt is determined to be non-  
dischargeable and it is further

ORDERED that the Defendant shall make payments in the sum

of Two Hundred Fifty Dollars (\$250.00) per month until the debt is paid in full. The first payment shall be due on January 1, 1992 with all subsequent payments due on the first day of each successive month until the judgement has been paid in full. Interest shall accrue at the rate of Ten Percent (10%) per annum from the date of this Order. If any payment is more than Ten (10) days late, or should be returned by the Bank due to insufficient funds, then in that event, the Stay of Execution is hereby lifted and post judgement remedies may procede against the debtor.


