ORDER GRANTING RECOVERY OF PREFERENTIAL TRANSFERS

Upon consideration of the Complaint for Recovery of Preferential Transfers filed by Roger M. Whelan, Trustee for the Chapter 7 bankruptcy estate of Computer Business Supplies, Inc. ("CBS"), debtor in the above-captioned case; and evidence in support of the Complaint having been heard at trial on February 2, 1993; and the Court finding: (1) that an interest of CBS in \$34,498.65 was transferred; (2) to or for the benefit of McCourt Label Company ("Mccourt Label"), defendant in the above-captioned case; (3) for or on account of an antecedent debt; (4) while CBS was insolvent; (5) during the 90-day period immediately preceding the filing of CBS's bankruptcy petition; and (6) that enabled McCourt Label to receive more than it would have received if the

case were a case under Chapter 7 of 11 U.S.C. §§ 101 et seq., the transfer had not been made and McCourt Label received payment of such debt to the extent provided by 11 U.S.C. §§ 101 et seq., it is this 9<sup>th</sup> day of February, 1993, by the United States Bankruptcy Court for the District of Maryland,

ORDERED That judgment be rendered against McCourt Label in the amount of \$34,398.65.
