**ORDER PERMANENTLY ENJOINING
DEAN A. HART FROM CONTINUING TO SERVE
AS A BANKRUPTCY PETITION PREPARER**

This matter came before the Court for further consideration of the United States Trustee's request to enjoin Dean A. Hart ("Hart"), as well as any sole proprietorships,

corporations, partnerships, limited liability companies, or any other type of business organization or entity that Hart may create, has an ownership interest in, or otherwise controls, from further acting as a Bankruptcy Petition Preparer in this or any other jurisdiction. Having held a hearing on this matter on January 18, 2008, at which evidence was presented indicating that Hart has continually engaged in conduct prohibited by 11 U.S.C. § 110(j)(2)(A)(i); and it further appearing that Hart has failed to turnover the sums of \$1,000 each to Kevin L. Joyner and Nakisha D. Joyner as required by the October 31, 2007 Order entered in this proceeding; and it further appearing that Hart has failed to answer the complaint filed in this proceeding, and that the allegations contained therein are therefore admitted pursuant to Fed. R. Civ. P. 8(d), it is hereby

ORDERED that, in addition to the relief previously granted in the October 31, 2007 Order entered in this proceeding, Hart, as well as any future sole proprietorships, corporations, partnerships, limited liability companies, or any other type of business organization or entity that Hart may create, has an ownership interest in, or otherwise controls, is hereby permanently enjoined from further acting as a bankruptcy petition preparer in this or any other jurisdiction.
