ORDER DIRECTING DISGORGEMENT OF FEE AND IMPOSING FINES ON BANKRUPTCY PETITION PREPARER AND ISSUING INJUNCTION FOR VIOLATION OF <u>11 U.S.C. § 110</u>

Upon consideration of the U.S. Trustee's Motion to Disgorge Fee and Impose Fines on Bankruptcy Petition Preparer For Violations of <u>11 U.S.C. § 110</u>, any responses thereto, after notice and an opportunity for hearing, good cause therefore having been stated in the Motion, that Cordae Scott is bankruptcy petition preparer, that Cordae Scott failed to disclose her services and the fee she charged the debtor in this case and, thus, violated <u>11</u> <u>U.S.C. § 110(h)</u>'s fee disclosure requirements, that Cordae Scott violated numerous other subsections of <u>11 U.S.C. § 110</u> in her efforts to hide her preparation activities from this Court, effectively preventing oversight, it is by the United States Bankruptcy Court for the District of Maryland, **ORDERED**, that the U.S. Trustee's Motion to Disgorge Fee and Impose Fines on Bankruptcy Petition Preparer for Violations of <u>11 U.S.C. § 110</u> be, and hereby is, GRANTED; and it is further

ORDERED, that, on or before fifteen (15) days after the date of the entry of this Order, Cordae Scott shall disgorge and refund to the debtor the \$575 fee the debtor paid Cordae Scott to assist the debtor in filing this case; and it is further

ORDERED, that, on or before thirty-five (35) days after the date of the entry of this Order, Cordae Scott shall pay damages to the debtor in the amount of \$2,000; and it is further

ORDERED, that, on or before thirty-five (35) days after the date of the entry of this Order, Cordae Scott shall pay fines in the amount of \$6,500 to the United States Trustee; and it is further

ORDERED, that after making the payments directed and required by this Order, and by no later than forty-five (45) days after the entry of this Order, Cordae Scott shall file in this case a statement under the penalties of perjury with the Bankruptcy Clerk's Office (the "Refund Statement"): (1) confirming that all payments ordered herein have been made; (2) identifying the amounts of the payments; (3) the manner in which the payments were made; and (4) the date(s) of the payments; and it is further

ORDERED, that Cordae Scott shall include her current and complete address for mailing in the Refund Statement; and it is further

ORDERED, that Cordae Scott shall serve a copy of the Refund Statement on the United States Trustee and the debtor; and it is further

ORDERED, that Cordae Scott is enjoined from acting as a bankruptcy petition

preparer.
