## COURT HEARING SCHEDULER (CHS) GUIDE

**Description:** The Court Hearing Scheduler provides objection deadlines and valid hearing dates/times, pursuant to the United States Code and local rules, for pleadings in which a separate notice of motion is required. All generated dates and deadlines are calculated based off the date of service of the notice of motion.

**Pleadings Utilizing CHS:** Motion to Sell Free and Clear of Liens, Sell, Sale of Property under Section 363(b), Notice of Intent to Sell, Borrow/Refinance, Authority to Obtain Credit, Relief from Stay, Relief from Co-Debtor Stay, Avoid Lien, Avoid Lien on Household Goods, Valuation of Collateral, Determination of Secured Status, Modify Chapter 13 Plan

**Notes:** The deadlines and hearing dates/times MUST be inserted into a notice of motion prior to the filing of a motion or amended notice of motion.
