Diamond Comic Distributors also does business using the names Alliance Games Distributors, Collectible Grading Authority, and Fandomworld. The debtors distribute comics, graphic novels, toys, games and pop culture merchandise.		
When was this case filed?	Diamond Comic Distributors, Inc. filed this Chapter 11 bankruptcy case on January 14, 2025 in the United States Bankruptcy Court, District of Maryland.
