

JUDGMENT AND ORDER ISSUING FINES, AWARDING DAMAGES AND ENJOINING DEFENDANTS

Upon consideration of the evidence presented at the hearing on October 2, 2012, and for the reasons stated on the record and in the findings of fact and conclusions of law

entered contemporaneously herewith, it is, by the United States Bankruptcy Court for the District of Maryland, **ORDERED:**

1. Judgment hereby is and shall be entered in favor of the Plaintiff, W. Clarkson McDow, Jr., United States Trustee for Region Four (the "United States Trustee"), and against the Defendants, Michael Mancini (a/k/a A. Michael Scalia, and f/k/a Michael A. Lonardo) and Scalia & Seidel, LLC (collectively, the "Defendants").

2. The Defendants shall pay to the United States Trustee the amount of \$153,000 as fines pursuant to 11 U.S.C. § 110(*l*). This amount consists of \$145,500 in fines relating to actions taken in connection with the cases identified in Exhibit 1 to this Order and \$7,500 in fines relating to actions taken in connection with the case of Linda D. Johnson, Case No. 12-14808-DER, United States Bankruptcy Court for the District of Maryland.

3. The Defendants shall pay each of the debtors identified in Exhibit 1 to this Order damages pursuant to 11 U.S.C. § 110(i)(1) in the amount of \$2,000. Said damages, totaling \$106,000, shall be provided to the United States Trustee in the form of certified checks or other certified funds made payable to each of the debtors identified in Exhibit 1 to this Order and the United States Trustee shall distribute those funds to the debtors.

4. The Defendants shall pay Linda D. Johnson damages pursuant to 11 U.S.C. § 110(i)(1) in the amount of \$2,000. Said damages shall be provided to the United States Trustee in the form of a certified check or other certified funds made payable to Linda D. Johnson and the United States Trustee shall distribute those funds to Ms. Johnson. 5. The Defendants shall refund the amount of \$468 to Linda D. Johnson pursuant to 11 U.S.C. § 110(h)(3). Said refund shall be provided to the United States Trustee in the form of a certified check or other certified funds made payable to Linda D. Johnson and the United States Trustee shall distribute those funds to Ms. Johnson.

6. Defendants shall be jointly and severally liable for the amounts set forth in paragraphs 2 through 5 above.

7. **INJUNCTIVE RELIEF:**

a. Except as provided in Paragraph 7(c) below, Defendants shall not:

i. Prepare any document for filing in a bankruptcy court;

ii. Direct any agent, representative, employee, associate, partner, entity, corporation, partnership, or association of any kind to prepare any document for filing in a bankruptcy court; or

iii. Assist any person or entity in drafting or preparing any document to be submitted to any bankruptcy court.

b. The Defendants shall not accept any money or other compensation from any person or entity for performing any act described in Paragraph 7(a) above.

c. Nothing in this Order shall be deemed or interpreted to prohibit, limit or otherwise abridge Defendant Michael Mancini's right to represent himself in any legal proceeding. The restrictions of Paragraph 7(a)

above shall not apply to any document Michael Mancini prepares or files in any court on his own behalf.

d. Nothing in this Order shall supersede, replace or amend any prior injunction entered against the Defendants. To the contrary, ANY PRIOR INJUNCTION ENTERED BY ANY COURT AGAINST EITHER ONE OR BOTH OF THE DEFENDANTS SHALL REMAIN IN FULL FORCE AND EFFECT.
