**FURTHER ORDERED**, that Defendants are hereby enjoined from engaging in any

conduct in violation of 11 U.S.C. § 110, including but not limited to (a) preparing any

documents for filing in a United States Bankruptcy Court without making all disclosures

required by 11 U.S.C. § 110, and (b) collecting or receiving any payment from any debtor

or on behalf of any debtor for the court fees in connection with the filing of a petition; and

**FURTHER ORDERED**, that unless first obtaining a license to practice law,

Defendants are hereby enjoined from engaging in any act constituting the practice of law,

including but not limited to advising any person of rights or obligations of the bankruptcy

code, advising any person as to what debts may be discharged in bankruptcy, advising any

person as to what exemptions may be available under federal or state law in a bankruptcy

proceeding, advising any person whether he or she is eligible to file bankruptcy, advising any

person as to what actions are stayed by the filing of bankruptcy, advising any person as to

what information must be contained in bankruptcy schedules or in other documents to be

filed in any United States Bankruptcy Court, or drafting, preparing or otherwise creating any

motion to be filed in a United States Bankruptcy Court.
