Hahn, declaring the debt owed by said Debtors/Defendants unto said Plaintiff in the principal sum of Ten Thousand Dollars (\$10,000.00) together with interest accruing thereon at





the rate of Ten Percent (10%) per annum from December 1, 1989, plus costs of suit, to be NON-DISCHARGEABLE, and it is further
